Highlights of Forty Years of Service in New Jersey

- 1976** Community Health Law Project established by the New Jersey State Bar Association and designated by the New Jersey Supreme Court as a legal aid society
- 1978** Successful CHLP suit ensures that community residences for people with disabilities may operate in residential districts
- 1978** CHLP advocacy leads to amending the NJ Law Against Discrimination to apply to people with mental disabilities
- 1985** Federal lawsuit in Mercer County opens federally subsidized housing to people with mental health disabilities
- 1988** Successful CHLP lawsuit prohibits state from terminating adult dependents with mental disabilities from health insurance coverage under their parents' State Health Benefits Plan
- 1994** CHLP receives U.S. Housing and Urban Development grant for work in removing architectural barriers in public accommodations
- 1995** Favorable Appellate Division ruling on CHLP - initiated suit forces NJ casinos to implement affirmative action programs of employment for people with disabilities
- 1996** CHLP statewide survey shows that only 4% of residential multifamily units comply with state and federal architectural barrier laws
- 1996** CHLP federal court suit results in invalidation of NJ municipal zoning laws that exclude group homes for people with disabilities from residential neighborhoods
- 2002** CHLP class action results in agreement by developer to fund \$300,000 worth of accessibility renovations in 266 residential units
- 2004** Successful CHLP precedent – setting Appellate Division decision excluding SSI benefits from being used for child support obligations of parents with disabilities in *Burns v. Edwards*
- 2005** CHLP successfully advocated for eliminating state and county institutional and hospital liens, and limiting cost of care for patients of public psychiatric hospitals
- 2005** CHLP successfully advocated for statewide ADA standards and compulsory training of local welfare agencies to identify and accommodate the special needs of people with disabilities
- 2005** CHLP advocacy leads to NJ Fair Housing Act amendment requiring all new multifamily Mt. Laurel housing to be adaptable for use by people with physical disabilities
- 2007** CHLP files federal court complaint against Port Authority of New York and New Jersey alleging that Jersey City PATH Station is inaccessible
- 2008** NJ Superior Court judge orders \$1.5 million worth of retrofits to make condos accessible in ADA v. Renaissance
- 2009** CHLP successfully advocated for a law requiring public official and commercial data companies to remove lien records of former psychiatric patients from public view
- 2013** CHLP received grants from Robin Hood Foundation, Kessler Foundation and Hurricane Sandy NJ Relief Fund
- 2014** PATH case settled with the agreement to construct an elevator and lift to give access to the Grove Street Station
- 2014** CHLP awarded Sandy Legal Assistance contract
- 2016** CHLP expands services to clients living with HIV/AIDS to seven counties.

Message from the Executive Director

The Community Health Law Project (CHLP) has continued its important role - assisting New Jersey's most vulnerable residents. During this past year, we continued our efforts to enroll individuals under the Affordable Care Act. We reached hundreds of people, informing them about health insurance and how to enroll. Staff assisted hundreds of uninsured or under-insured individuals to enroll in the Federal Health Insurance Marketplace or in NJ Family Care, the state's Medicaid program.

Our attorneys and advocates have also provided information, counsel, and representation in a variety of matters including individuals and families still devastated by Superstorm Sandy. Staff have helped to connect people to state and federal assistance programs, and helped to address housing issues such as tax reductions, mortgage foreclosure settlements, landlord disputes, and litigated matters related to contractor work or contracts.

We have continued our services to help persons living in the community who are receiving home health services including personal care assistance, private duty nursing, and durable medical supplies, and to help resolve issues concerning the amount of care received and continuation of care.

We are pleased that we have been able to expand our legal and advocacy services to persons living with HIV/AIDS. We now provide services to residents of Mercer, Passaic, Bergen, Monmouth; and soon to those living in Atlantic and Cumberland. Additionally, we continue to serve individuals under our Ryan White grant from the Newark EMA serving Essex, Morris, Warren and Sussex.

The above-mentioned efforts are only a small part of the overall activities of the CHLP. Over 4,500 persons were served this fiscal year. Staff represented 2,696 individuals in various civil legal matters including public benefits eligibility, family issues, housing, foreclosure, and consumer problems.

Our five regional offices and four satellite offices allow our staff to be accessible throughout the state and to serve our clients in their local area.

Today we face a most unsettled state and country with a new president, a one-party federal government, and an upcoming state election with a new governor to be elected. Despite the potential upheaval, we are proud and pleased that the CHLP continues to be a valued, successful, and important part of the safety net. The Law Project's Board and staff remain dedicated to assuring that the rights and entitlements of New Jersey's residents living with disabilities have a strong voice acting on their behalf.

The Year in Review: July 2015 - June 2016

The Community Health Law Project staff have represented our clients in a myriad of civil matters. Some examples of the types of cases that we have been involved in this fiscal year include:

- **Special Education** - In a case involving a youth with special needs, our attorney was able to secure an out-of-district educational placement for a child on the autism spectrum. The child is now making measurable progress at a reputable private school that specializes in Autistic Spectrum Disorder. When the child's mother originally came to CHLP, she had already filed for Due Process. However, we agreed to withdraw the complaint without prejudice if the school district performed certain requested evaluations, including a neuropsychological evaluation. We were able to use the results of these evaluations to secure the out-of-district placement without the need for a full Due Process Hearing, saving the child and his mother significant time and money.
- **Superstorm Sandy** - MP is a Super Storm Sandy survivor. She had applied for Increased Cost of Compliance benefits in 2013 and was denied. With our assistance, she was recently deemed eligible for these benefits, now allowing her to receive up to \$30,000 towards her recovery from the 2012 storm.
- **DAC Medicaid** - CHLP has had a couple of cases involving the DAC Medicaid exception and clients being terminated from Medicaid. The DAC Medicaid exception provides that if recipients are on Supplemental Security Income (SSI) and then receive Disabled Adult Child (DAC) benefits at a level that would normally make them ineligible for Medicaid, that the individuals continue to be eligible for Medicaid. DAC eligibility requires that a parent be eligible for Social Security retirement or disability benefits or be deceased.

This pattern would seem to raise a question as to how often Medicaid offices are incorrectly denying DAC Medicaid exception applicants. In addition to the various Boards of Social Services and Medicaid offices not understanding the DAC exception, parents, guardians and clients themselves are unlikely to understand the DAC Medicaid exception. There may be a systemic problem with Medicaid offices and the DAC exception. CHLP will continue to protect its clients who are eligible for the DAC Medicaid exception.

- **Social Security** - CHLP recently closed a case started in July, 2003. We represented a woman seeking SSI benefits and Social Security Disability Benefits who had serious mental health issues due to multiple causes including a history of rape and other abuse. The case had to be appealed to the United States District Court four times. Each time the Social Security Administration agreed to remand the case without having a judge make a decision. Finally, an Administrative Law Judge agreed that we had been correct and granted full SSI benefits. Unfortunately, Social Security Disability Benefits were not awarded. The client received tens of thousands of dollars in retroactive benefits.
- **Home Health Care** - Staff represented a developmentally disabled client who was denied approval by the Medicaid HMO for a nurse to accompany the child to a preschool program. Staff met with the family and the preschool and provided medical documentation concerning the child's condition and the need for continuous nursing care. The HMO, after receiving the appeal, approved the nursing care for the child at the preschool program.
- **Foreclosure** - Staff represented a client who had entered into a mortgage modification agreement, but had fallen behind in payments. After reviewing the client's financial and medical situation, staff assisted in the submission of an application to Social Security. After initial denial, the client was successful at the hearing level. With the successful Social Security matter resulting in benefits to the client, staff negotiated with the lender to dismiss the foreclosure application and implement the balance forgiveness provisions of the modification agreement.

In another case, staff represented a client who had fallen behind in her mortgage after losing her job. A foreclosure complaint was filed and after the proceedings, a sheriff's sale was scheduled. Staff assisted the client in an application for her pension and advised the sheriff's office that a negotiation might ensue. Staff also helped the client to apply for Hardest Hit Funds, and upon the application being approved, the lender agreed to adjourn and then dismissed the sheriff's sale.

Since 2000, **Kathy Collins** has been the Executive Director of MonmouthCares, laying the groundwork for what has become a key component in what has become NJ's nationally recognized Children's System of Care (CSOC). The central premise of the CSOC is that families are equal partners in the planning for their children's success despite serious challenges. The collaboration at the heart of this movement encouraged Kathy to participate in the reform of NJ's Juvenile Justice System (JJS), one of five model sites in the US supported by the Annie E. Casey Foundation.

John Jacobi teaches, researches, and works in the areas of health care access, finance and delivery reform, as well as disability rights and mental health discrimination. He is the Faculty Director of the Seton Hall Law School Center for Health & Pharmaceutical Law & Policy. He is a board member of the Greater Newark Healthcare Coalition and North Jersey Community Research Initiative. He participates in legislative and regulatory advocacy on behalf of low and moderate income residents. He has served as Principal Investigator for research projects in health reform, health access and behavioral health areas. He has served as Senior Associate Counsel to the Governor of NJ, as Assistant to the Commissioner of the NJ Public Advocate, and as Gibbons Fellow in Public Interest and Constitutional Law.

Denise Pipersburgh practices in the area of general corporate representations and employment law. She regularly authors scholarly and practical articles for legal and industry publications on labor and employment law issues affecting employers around the country. Denise mentors current and prospective law students with disabilities through the American Bar Association's Commission on Disability Rights. She serves on the Board of Trustees for the New Jersey Metro Chapter of the National Multiple Sclerosis Society, and served as co-chair for the Chapter's 2nd Annual Address to the Business Community reception and dinner; the Board of Directors for Makeover Your MS, Inc., noted for her achievements in the Kessler Rehabilitation's Here's To our Heroes 2015 Calendar; and was featured in web video series through www.everydayhealth.com.

Wardell Sanders is a recognized expert on health care policy, speaking to national and regional audiences, and is a frequent commentator on TV. In 2014, *Inside New Jersey* and *Star-Ledger* writers named him one of New Jersey's 100 most influential residents. Ward has partnered with providers and advocates to find ways to overcome the many challenges and barriers that face consumers in general and specifically those persons living with disabilities. He has served for 15 years in state government positions—Executive Director of the New Jersey Individual Health Coverage Program/Small Employer Health Benefits Program Boards and as Deputy Attorney General.

Janet Sharma stepped down as CEO of the Volunteer Center of Bergen County, where she had served since 1993, and continued to lead a Hurricane Sandy recovery project. Under her leadership, the Volunteer Center was designated by Points of Light as a Volunteer Center of Excellence. She received the "Woman of Distinction" award from Senator Robert Menendez. Her civic leadership has been recognized by the Meadowlands Regional Chamber, WCBS-880, the Girl Scout Council of Northern New Jersey, Urban League, Hispanic Business Council and Junior League of Bergen County.

Jim Thebery has worked in the Division on Disability Services since 1994 and was named Director of the Bergen County Division on Disability Services in September 1999. He has been a strong proponent of self-advocacy as persons with disabilities seek equality and opportunities. He instituted a state-wide campaign to establish (*Access for All*) committees in all municipalities of the state to address accessibility issues concerning residents with disabilities. Jim also introduced the "*Come & See, All Are Welcome*" campaign to ensure accessibility in houses of worship, through education and examples. These sessions geared for religious and laity have been held in Catholic, Protestant and Jewish houses of worship. In collaboration with Bergen/Passaic Girl Scouts, he sponsored the 2009-2010 *Municipal Access Award* for a community demonstrating outstanding access and accommodations for residents with disabilities.

CHLP's Programs and Services

The essential mission of the Community Health Law Project is to provide legal and advocacy services to New Jersey residents with disabilities. We serve consumers of mental health services, people with physical disabilities, HIV/AIDS, developmental disabilities, and visual impairments. Our attorneys and advocates represent clients in matters involving Social Security benefits, welfare, food stamps, and other entitlements; housing habitability and landlord/tenant disputes; foreclosure defense; consumer protection and debt collection; child support and domestic violence; Medicaid, Medicare, and other health insurance issues; civil rights; and barrier-free accessibility. In FY2016 (July 1, 2015 to June 30, 2016), CHLP represented 4,516 clients.

An example of how the Law Project's direct services adjusts to the needs of our clients is the continuing crisis of foreclosures facing New Jersey residents. During the last few years, various media outlets have spoken about the foreclosure epidemic continuing to be a crisis. Unfortunately, New Jersey has stood high on the list of states facing this situation. An article in *The Star-Ledger* this past summer stated that New Jersey might well have the nation's highest rate of foreclosures in a large number of properties mired in the process. With many of our clients being low-income, as well as a large number being aged, our staff have addressed this problem by assisting clients to either overt foreclosure or work out settlements that enable them to stay in the property or have sufficient time to find other housing.

In addition to the examples of services described above, CHLP operates several unique programs:

To Your Health. The program concentrates on two important issues facing our clients: providing assistance to individuals with mental health and co-occurring addictions to enroll under the Affordable Care Act in the new Medicaid Expansion Program and the Healthcare Marketplace. For other clients, we have assisted and represented individuals receiving home health care who have had their health care services denied, terminated or reduced by the health care insurance carrier.

Student Internship Program. Since 1988, CHLP has been holding its annual Ann Klein Advocate Awards, the proceeds of which support its student internship program. Using these funds, as well as funding from Legal Services of New Jersey, CHLP has been able to hire several law students and graduate students every year to work in its branch offices on direct legal services, and its South Orange office on civil rights cases. In so doing, CHLP helps to train and inspire the next generation of disabilities advocates and attorneys.

Civil Rights and ADA Litigation. For many years the CHLP has been a leading voice and advocate for clients in Fair Housing and Americans with Disabilities litigation. Staff continues to assist clients in asserting their rights and seeking accommodations.

Training and Workshops. CHLP offers a wide range of workshops for consumers and professionals. With the support of the New Jersey State Bar Foundation, it presents an annual Law & Disability Issues Conference at the New Jersey Law Center in New Brunswick every spring. Subjects range from civil rights cases to health care issues to new laws affecting people in institutional settings. CHLP staff is always ready to speak on the entire range of legal topics that affect the organization's clients. The staff also offers interactive workshops on the civil rights of persons with disabilities and on health care issues.

Public Policy Advocacy. CHLP staff has continued to address system-wide issues that affect our clients in a number of ways. For example, we participated in statewide coalitions such as the New Jersey Anti-Poverty Network and the Affordable Housing Network and various county professional advisory committees to local mental health planning boards. We took active roles in the government affairs committees and activities of statewide organizations such as Disability Rights New Jersey, the Mental Health Association in New Jersey, The Arc of New Jersey, and New Jersey Association of Mental Health and Addiction Agencies. Our direct service staff attorneys and advocates participated in numerous local advisory boards and task forces around the state addressing issues such as homelessness, mental illness, developmental disabilities, Social Security, HIV/AIDS services, prisoner reentry and human services. In addition, our attorneys and advocates provided community education and training around the state on a variety of topics of concern to people with disabilities. An example of this effort is our South Jersey office attending monthly meetings with the public policy sub-committee of the Mental Health Association of Southwestern New Jersey's Board working on getting the Camden County Board of Social Services to be more responsive and sensitive to the needs of mental health consumers and improving access to their services; and providing training to boarding home/residential health care facility operators and residential services providers on Social Security issues.

Fee-for-Service Program. The CHLP has initiated a Fee-for-Service (FFS) representation program for individuals with disabilities whose income exceeds CHLP's income guidelines to obtain free legal representation or for those individuals with disabilities for whom CHLP has no funding to provide free legal representation. Under the FFS program, CHLP bills its legal services on a sliding scale, from \$125 to \$175 per hour, depending on the client's income. Legal services are provided in such areas as special education, social security, special needs trusts, health insurer's denial of coverage or services, guardianships, expungements, name changes, wills, living wills, powers of attorney, fair housing and ADA issues, and certain other civil law matters.

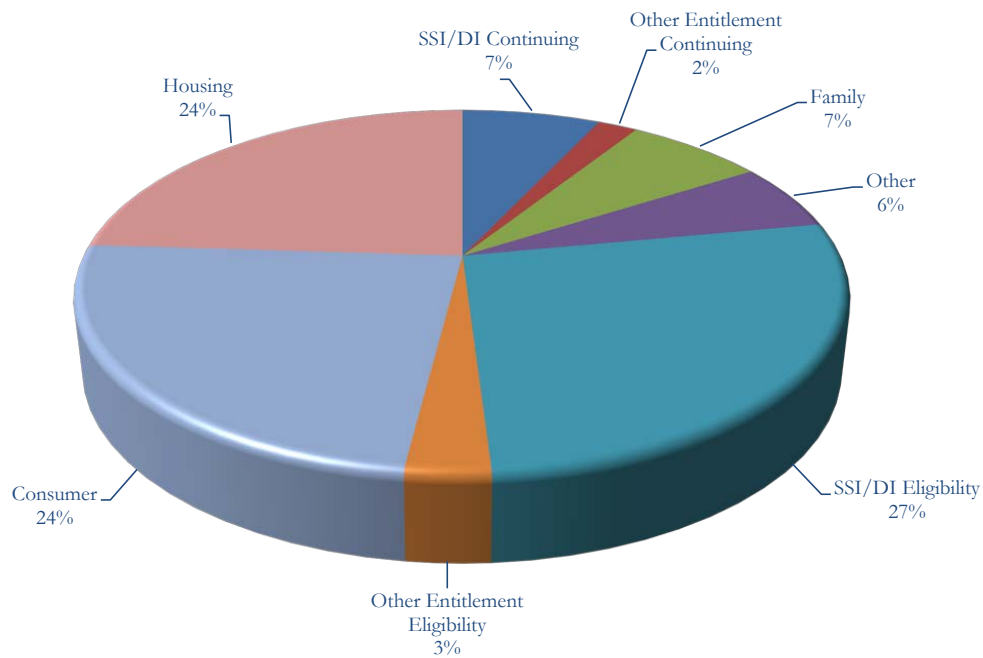

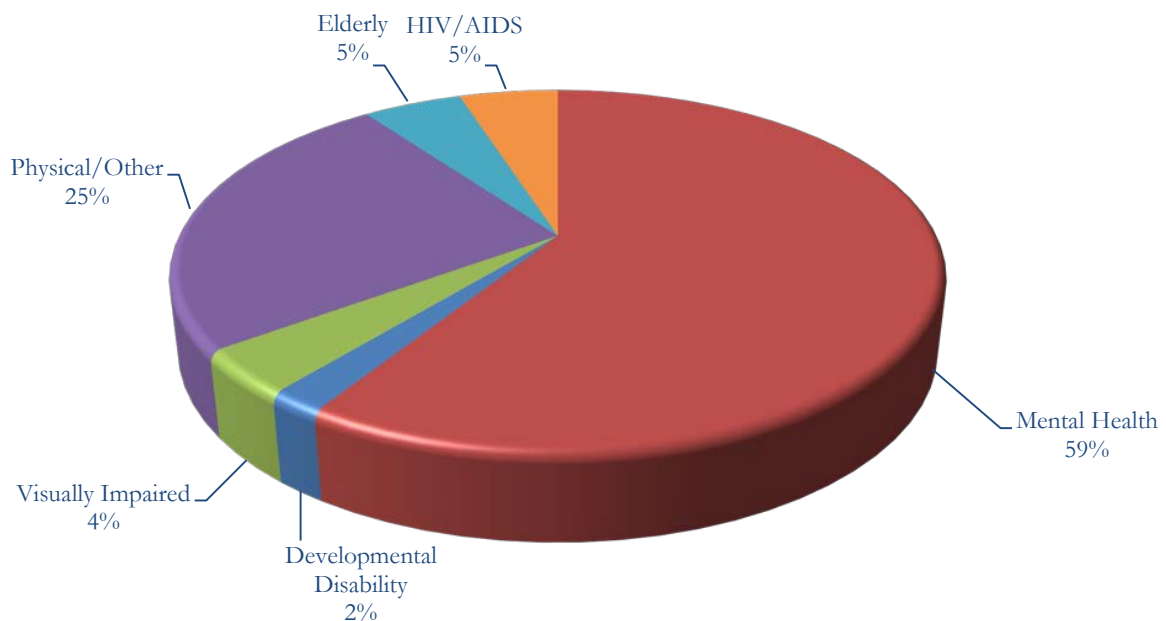
